This FUTURE ENTERPRISES PTE LTD (the "Cookie Policy") describes the different types of cookies that are used in connection with the website owned and controlled by FUTURE ENTERPRISES PTE LTD, stated in the terms of use of the website or in the rules & regulations of the marketing campaign that the website refers to, or any other website from which You get access to the Cookies Policy. FUTURE ENTERPRISES PTE LTD determines the means and purposes of the data processing described in this Cookie Policy. FUTURE ENTERPRISES PTE LTD (hereinafter “Company”) does not collect or analyze personal data of the www.maccoffee.com/kz-en website users, therefore, cannot be considered as a personal data operator (incl. according to the Kazakhstan law as of 21.05.2013r. N 94 - V ZRK "On the protection of personal data").

You have the option of agreeing to the use of cookies prior to entering to this Site. This Cookie Policy allows you to consent or refuse to consent to each category of cookies (except Strictly Necessary Cookies, which can only be rejected).

WHAT IS A COOKIE?

Cookies are a standard feature of websites that allow us to store small amounts of data on your computer about your visit to the Site. They are widely used to help make websites work or work in a better, more efficient way, such as by recognizing you and remembering information that will make your use of the website more convenient (such as by remembering your preference settings). Cookies also help us to learn which areas of the Site are useful and which areas need improvement, and to track your usage of the Site to provide you with targeted advertisements.

- ***First-party cookies and third-party cookies***

Cookies are downloaded by your internet browser the first time you visit the Site. The next time you visit the Site from the same device, the cookie and the information stored in it is either sent back to the site that generated it (first-party cookie) or to a different website to which it belongs (third-party cookie).

These third-party providers set cookies when you are logged on to their pages and visit our Site. We have no influence on the cookie settings of these websites. Please visit the websites of third-party providers to obtain further information on how they use cookies.

First-party and third-party cookies enable the website to recognize whether you have already accessed the Site through this browser and, in many cases, it then makes the content displayed vary.

If you deny the use of all cookies, neither first-party cookies nor third-party cookies will be used. There will be no differentiation between both types of cookies.

- ***Persistent and session cookies***

Depending on their lifespan, Cookies can be distinguished between “persistent” or “session” cookies.

A persistent cookie is a cookie that is stored on your computer until it expires or you delete it.

A session cookie, on the other hand, is deleted when you close your browser.

Apart from the acceptance of cookies when visiting the Site as described in the way set out below you generally can choose whether to accept cookies by changing the settings on your browser. For further details, see below under No. 2.

HOW DO I MANAGE COOKIES?

- ***Disagree to the use of cookies***

You have the option of agreeing to the use of cookies that will enable you to use all functions of the Site without restrictions when visiting our Site. If you do reject the use of Strictly Necessary Cookies, this may impact your user experience and functionality while using the Site. The rejection of other cookies may not impact your user experience and functionality while using the Site.

If you reject the use of all cookies, first-party and third-party cookies will be deactivated. Moreover, first-party cookies will be deleted. We are not able to delete any third-party cookie. Therefore, you have to delete third-party cookies on your own. This can be done within the settings of your browser (see next bullet).

- ***Deactivate and/or delete cookies via your browser***

Alternatively and/or in addition, you can change your cookie settings within your internet browser. Your internet browser allows you to change your cookie settings. Such browser settings for cookies are typically found in the “options”, “tools” or “preferences” menu of your internet browser. You may also consult the browser’s “help” menu. Different browsers may use different mechanisms to disable cookies.

There are online tools available for clearing all cookies left behind by the websites you have visited, such as www.allaboutcookies.org.

When you visit this Site from different computers, it will be necessary to repeat the modification of your settings.

WHAT KIND OF COOKIES DO WE USE?

Below we list the different types of cookies that we and third parties use on the Site: Strictly Necessary Cookies, Performance Cookies, Functional Cookies, Targeting Cookies and [Social Media Cookies].

Strictly Necessary Cookies

Strictly Necessary Cookies guarantee functions without which you would not be able to use this Site and ensure amongst others that, when you call up the functionalities of a website, you are shown a version that has a broad-band-related data quantity corresponding to that of the Internet connection you are using. Moreover, such cookie takes care that, in the case where you change pages, the function of changing from http to https takes place. In addition, cookies of this type store your decision regarding the use of cookies on our Site.

In particular, the Strictly Necessary cookies that we use are:

1. cookies which are solely used for carrying out the transmission of the communication over the internet; and
2. cookies which are strictly necessary in order for us to provide you the service that you explicitly requested (i.e. if these cookies are disabled, we won't be able to provide you with the service that you have expressly requested).

The use of Strictly Necessary Cookies for the purposes described above is based on our legitimate interests to ensure the proper technical functioning, access and use of the Site, and provide you with the service(s) that you explicitly requested.

Performance Cookies

These cookies are used to provide us with statistical information about performance of our Site (e.g. to count visits, traffic sources).

Functional cookies

These cookies allow the Site to remember choices you make and provide enhanced, more personal features. This category may include third-party cookies.

Targeting Cookies

Targeting cookies are set to display targeted advertisements based upon your interests on the Site or to manage our advertising. These cookies collect

information about your activities on this Site and other sites to provide you targeted advertising.

Social Media Cookies

Social media cookies collect information about social media usage, to build your profile.
